We process data that you have provided to us in the context of our business relationship. This includes, in particular, the following information:

- Contact details of the supplier's contact person, such as title, name, business address, phone number, and email address.
- Changes to address or master data.
- Data for payment processing, such as bank details.

Where legally permissible and necessary for the provision of our services, we also process personal data from publicly accessible sources (e.g., commercial register, internet, authorities). This primarily includes the following data:

- Business address and names of managing directors.
- Business address and names of shareholders (as far as visible from commercial registers).

We collect and process your personal data as part of initiating and fulfilling our contractual obligations (e.g., contact data for the conclusion of a supplier contract). The legal basis for this is derived from Art. 6 (1) lit. b) GDPR. To protect our legitimate interests, we also process your data based on Art. 6 (1) lit. f) GDPR. We have a legitimate interest in using your data to conduct credit checks and collect claims, including by engaging collection agencies. Additionally, we process your data to assert legal claims and defend against legal disputes in accordance with Art. 6 (1) lit. c) GDPR.

Your data is processed within our company by the relevant departments. As part of our procurement activities, we also use processors. Your data is shared in strict compliance with GDPR regulations.

Your data is stored only for the necessary period. Once it is no longer required for the purposes mentioned above, it will be deleted in accordance with statutory retention obligations.

In connection with the processing of your personal data, you have the following rights:

- Under Art. 15 GDPR, you have the right to obtain information about the data stored by us.
- Under Art. 16 GDPR, you have the right to have incorrect data corrected.
- Under Art. 17 GDPR, you have the right to request the deletion of your data unless there are legal reasons for further storage.
- Under Art. 18 GDPR, you have the right to request the restriction of the processing of your personal data.
- Under Art. 20 GDPR, you have the right to data portability for all data you have provided to us.

Additionally, you have the right at any time to object to the processing of your personal data for reasons arising from your particular situation under Art. 21 GDPR. We will stop processing your personal data unless we can demonstrate compelling legitimate grounds for processing that outweigh your interests, rights, and freedoms, or if the processing is for the establishment, exercise, or defense of legal claims.

You also have the right to revoke any consent you have given us at any time. This will not affect the lawfulness of the data processing carried out on the basis of your consent before its withdrawal. If you wish to exercise your right of withdrawal, you can send an email to privacy@bricon.com

If you believe that we are violating the General Data Protection Regulation by processing your personal data, you have the right to file a complaint with a supervisory authority. The responsible supervisory authority for us is:
